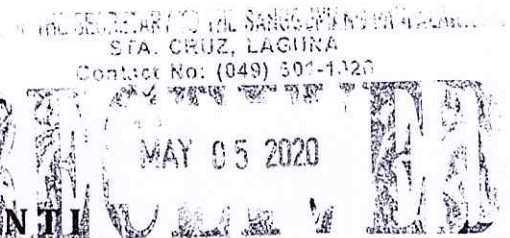

#### MUNICIPAL ORDINANCE NO. 015 - 2020

**AN ORDINANCE GRANTING CASH GIFTS TO CAVINTINIAN ELDERLY AGES 90-99 IN THE MUNICIPALITY OF CAVINTI LAGUNA AND APPROPRIATING FUNDS THEREFORE.**

**WHEREAS**, the Cavinti Municipal Government of Laguna recognizes the intention of the author to give honor and due recognition to those individual within the municipality of Cavinti Laguna who reached ninety to ninety nine (90-99) years old existence. As provided for under Republic Act No. 9994 otherwise know as “ AN ACT GRANTING ADDITIONAL BENEFITS AND PRIVELEGES TO SENIOR CITIZENS, FURTHER AMENDING REPUBLIC ACT NO. 7432, AS AMENDED, OTHERWISE KNOWN AS ACT TO MAXIMIZE HE CONTRIBUTION OF SENIOR CITIZENS TO NATION BUILDING GRANT BENEFITS AND SPECIAL PRIVILEGES AND FOR OTHER PURPOSES.”

**WHEREAS**, Section 1 of Republic Act No. 7432, as amended by Republic Act No. 9257, otherwise known as the “Expanded Senior Citizen Act of 2003”, is hereby further amended to read as follows;

*“Section 1. Declaration of Policies and Objectives- As provided in the Constitution of the Republic of the Philippines, it is the declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life.”*

*“Article XV, Section IV of the Constitution further declares that it is the duty of the family to take care of its elderly members while the state may design programs of social security for them.”*

**WHEREFORE**, in view of these, on motion of SB Member Elma P. Flores, Chairman of the Committee of Social Services, duly seconded and by unanimous consent of all the members present, there being a quorum, it was

The Sangguniang Bayan , through this special session hereby enacted that

**SECTION 1. Short Title.** – This Ordinance shall be known as the “Cavintinian Elderly Ordinance of the Municipality of Cavinti Laguna.”

**SECTION 2. Scope.**- This Ordinance shall find application only within the territorial jurisdiction of the Municipality of Cavinti Laguna.

**SECTION 3. Declaration of Policy** – It is the policy of the Municipal Government of Cavinti Laguna to honor and recognize its constituents who reached the age of ninety (90) to ninety nine (99) years old, and their contributions to their family, community and society.

**SECTION 4. Qualifications –**

a) Person who are qualified are:

- i. All living Cavintinian and residents of Cavinti Laguna who reached the age of ninety (90) to ninety nine (99) years old and above; and
- ii. Cavintinian elderly who have reached the ages of 90-99 and can submit documents for validation such as birth certificate or any government-issued ID that indicates his or her birthdate.

b) It must established that the elderly is a Cavintinian and bonafide resident of the Municipality of Cavinti Laguna for at least three (3) years as certified by the Barangay Chairman and Municipal Social Welfare Development Officer of the municipality.

**SECTION 5. Cash Gifts**

a) Cavintinian elderly with the following ages are awarded cash gifts on yearly basis on the day of their birthday:

AGES	CASH GIFTS
a. 90-93 years old	Two Thousand pesos (P2,000.00)
b. 94-96 years old	Two Thousand Five Hundred pesos (P2,500.00)
c. 97-99 years old	Three Thousand pesos (P3,000.00)

**SECTION 6. Implementing Rules and Regulation** – upon the approval of this Ordinance, the Municipal Social Welfare and Development Office (MSWDO) shall prepare the necessary guidelines to be approved by the Municipal Mayor, and shall take the lead in the effective implementation thereof;

**SECTION 7. Funding.** – The appropriate funds needed for the implementation of this Ordinance shall be taken from the general appropriations of the municipality of Cavinti Laguna;

**SECTION 8. Repealing Clause.** – Any ordinances, resolutions, orders, rules and regulation and other issuances of the Municipal Government of Cavinti, Laguna that are contrary or inconsistent with this Ordinance are hereby repealed, amended, or modified accordingly;

**SECTION 9. Separability Clause.** – If for any reason, any section of this Ordinance, or any portion hereof or the application of such section provision, or portion hereof to any person, group, or circumstance is declared judicially invalid, unlawful, unconditional, or unconstitutional, the remainder shall be in full force and effect.


**SECTION 10. Effectivity.** – This Ordinance shall take effect immediately upon approval.
