**RESOLUTION ADOPTING THE MUNICIPAL PEACE AND ORDER COUNCIL (MPOC) RESOLUTION NO. 02-2021 ENTITLED " RESOLUTION RECOMMENDING THE APPROVAL OF PEACE AND ORDER FUND AMOUNTING TO PHP 2,349,000.00 TO BE UTILIZED FOR THE PROGRAMS, PROJECTS AND ACTIVITIES OF MUNICIPAL PEACE AND ORDER COUNCIL (MPOC), MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC), AND END LOCAL COMMUNITIS ARMED-CONFLICT (ELCAC) TASK FORCE AND CAVINTI PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN 2020-2022.**
