on the first Monday of February 2023 after the Flag raising ceremony;

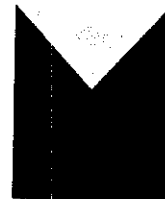
**NOW THEREFORE**, in view of the foregoing, upon motion of SB Charles Clifford
