MUNICIPAL ORDINANCE NO. 008 - 2023

AN ORDINANCE PROVIDING FOR FREE ANNUAL BLOOD CHEMISTRY TEST FOR SENIOR CITIZENS AND OTHER PURPOSES IN THE MUNICIPALITY OF CAVINTI, LAGUNA.

Sponsor : SB Charles Clifford F. Matta

**WHEREAS**, Section 11 , Article III of the 1987 Constitution, provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost;

**WHEREAS**, Republic Act No. 7432 otherwise known as *AN ACT TO MAXIMIZE THE CONTRIBUTION OF SENIOR CITIZENS TO NATION BUILDING, GRANT BENEFITS AND SPECIAL PRIVILEGES AND FOR OTHER PURPOSES*, aims to establish a program beneficial to the senior citizens and the rest of the community that they serve;

**WHEREAS**, Section 16 of Republic Act 7160, otherwise known as the Local Government code of 1991, provides that "Every Local Government Unit shall exercise the powers expressly granted, xxx and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall, xxx promote health and safety;

**WHEREAS**, the Municipality of Cavinti, Laguna under the administration of the Municipal Mayor, Hon. Arrantlee R. Arroyo has initiated the "*free blood chemistry test for Senior Citizens*" program under the Municipal Social Welfare and Development Office and the Municipal Health Office;

**WHEREAS**, Section 4, of Republic Act No. 9994 also known as the Senior Citizens Act of 2010 provides that the senior citizens shall be entitled to free medical and dental services, diagnostic and laboratory fees such as, but not limited to , x-rays, computerized tomography scans and blood test, in all government facilities, subject to the guidelines to be issued by the Department of Health in coordination with the Philippine Health Insurance Corporation (PHILHEALTH);

**WHEREAS**, the Municipality of Cavinti, Laguna prioritizes the health and well-being of its elderly by providing access to medical services free of charge regardless of the financial capability of the aforementioned beneficiaries which would be a great help in order to monitor the health condition and prevention of diseases or recurrence thereof, and for our medical health providers to prescribe treatments and medications for identified medical conditions.

**WHEREAS**, what Mayor Arrantlee R. Arroyo started is highly commendable and should continue and remain a legacy of his administration and that of the local council.

**NOW THEREFORE**, in view of the foregoing, the Sangguniang Bayan duly assembled hereby enacts

**ARTICLE I**

**GENERAL PRINCIPLES AND POLICIES**

**SECTION 1. Short Title** – This ordinance shall be known as “*AN ORDINANCE PROVIDING FOR FREE ANNUAL BLOOD CHEMISTRY TEST AND OTHER PURPOSES IN THE MUNICIPALITY OF CAVINTI, LAGUNA*”.


**SECTION 2. Purpose.** This Ordinance aims to provide a wider coverage of health services to the senior citizens of Cavinti, Laguna that are greatly in need of medical assistance, to promote the well-being of our elderly regardless of their financial capability by providing them with free blood chemistry test, and other purposes.

**SECTION 3. Scope.** Other health services and diagnostic tests included but not limited to the following that shall be made available in the future may be covered by this ordinance, subject to financial capacity of the local government.

**3.1 Blood Chemistry**

- i. Serum Glumatic-, Oxaloacetic Transaminase (SGOT)/Aspartate Aminotransferase (ALT);
- ii. Serum Glumatic Pyruvic Transaminase (SGPT)/ aspartate Aminotransferase (ALT)
- iii. Serum electrolytes
- iv. Random Blood Sugar (RBS)
- v. Acid- Fast Staining
- vi. CD4 Count Test
- vii. Triglycerides
- viii. High-Density Lipoprotein (HDL)
- ix. Low-Density Lipoprotein (LDL)



- ii. Blood Banking and Serology Tests
- iii. Hematology Tests
- iv. Dental Check-up
- v. Eye Examination
- vi. X-ray
- vii. ECG
- viii. Ultrasound
- ix. GeneXpert Test for Tuberculosis
- x. Rapid Antigen Test for COVID 19

**SECTION 4. Coverage.** The person who shall avail of the aforementioned health services must be:

1. Legitimate resident of Cavinti, Laguna; and
2. Registered senior citizen holding a Senior Citizen ID/OSCA ID of the Municipality of Cavinti.

**SECTION 5. Funding Requirement.** The Local Government Unit of Cavinti shall allocate the amount of not less than Five Hundred Thousand Pesos (P500,000.00) fund for the implementation of this ordinance and thereafter;

**SECTION 6. Implementation.** The Municipal Social Welfare and Development Office and Municipal Health Office of this municipality shall facilitate and ensure the implementation of this ordinance;

**SECTION 7. Separability Clause.** - If any provision of this Ordinance is declared void or unconstitutional, the remaining portions shall not be affected and shall remain in full force and effect.

**SECTION 8. Repealing Clause** – Any and all provisions of existing ordinances which appear to be inconsistent herewith are deemed modified or repealed.

**SECTION 9. Effectivity**– This Ordinance shall take effect after fifteen (15) days following its publication or posting of copies in the Official Website and/or Social Media Account of the Office the Sangguniang Bayan and/or in any conspicuous locations within the Municipality of Cavinti, Laguna.

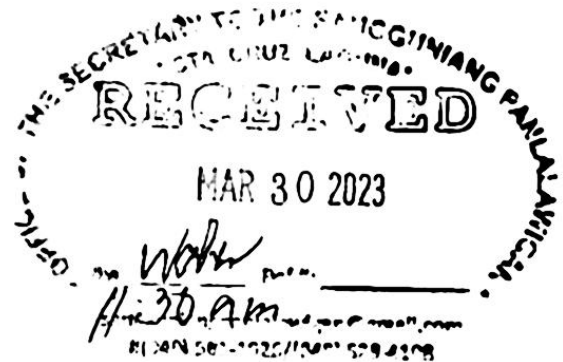
