MUNICIPAL ORDINANCE NO. 17 - 2023

AN ORDINANCE ESTABLISHING AN AWARDS SYSTEM FOR THE CONSECUTIVE THREE-TERMER ELECTIVE BARANGAY OFFICIALS OF THE MUNICIPALITY OF CAVINTI, AND APPROPRIATING FUNDS.

WHEREAS, the vital role of the Barangay Officials as an instrument in the implementation and success of the Government Agenda must be recognized by the Municipal Government of Cavinti;

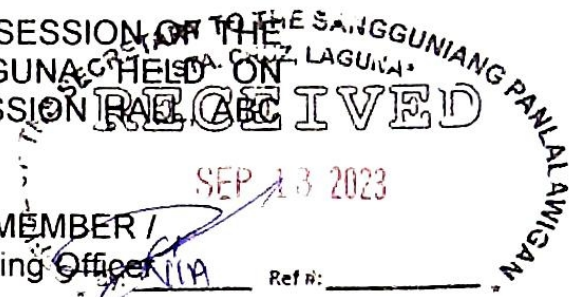
WHEREAS, their role in governance was so critical and significant that project outcomes were dependent upon their capability, capacity and ability in the delivery of basic services;

WHEREAS, this system is giving motivation to dedicated barangay officials to improve their performance;

WHEREAS, there is a need to establish an Awards system to the three-termer elective Barangay Officials of the municipality to fittingly honor and appreciate their hard work and dedication to the public service;

NOW THEREFORE, be it ordained by the Sangguniang Bayan, in session duly assembled that:

Section I - TITLE. This Ordinance shall be known as "An Ordinance Establishing an Awards System for the Consecutive Three-Termer Elective Barangay Officials of the Municipality of Cavinti, Laguna."

Section II - SCOPE AND COVERAGE. This Ordinance shall govern the giving of awards to all elective Barangay Officials who have completed their Three (3) Consecutive Terms in the same position.

Section III - RECOGNITION AWARDS. All Barangay officials who have completed the three (3) consecutive term for the same position shall be given a Certificate of Recognition and a cash incentives of

- a) **Punong Barangay** -Total of Php15, 000.00 for three term
- b) **Barangay Kagawad** -Total of Php9, 000.00 for three term

And to be given by the Municipal Mayor and shall subject to the availability of funds.

Section IV - NOMINATION AND QUALIFICATION. The Sanggunian Bayan Member who is the Chairman of Barangay Affairs shall nominate the Elective Barangay Official who shall meet the following requirements:

- 1. Should have completed three (3) consecutive Term
- 2. Should have not been penalized involving administrative, criminal and civil cases;
- 3. Should have not been involved in any cases of moral turpitude.

Section V - AWARDS COMMITTEE. The office of the Mayor shall form an awards committee who will determine, evaluate the nominees and shall make the final recommendation for the proposed recipient of the said award to be approved by the Municipal Mayor;

Section VI - AWARDING. The Certificate of Recognition shall be given during the **Annual Event of SAMBALILO FESTIVAL** or in an appropriate ceremony scheduled at the end of the term of the recipient of the three term elective Barangay Officials.

Section VII - FUNDING. The Municipality of Cavinti, Laguna shall appropriate fund for the Certificate of Recognition and Cash Incentives to be given to the qualified Barangay official mentioned in the preceding section.

Section VIII - SEPARABILITY CLAUSE. - If any provision or part hereof is held invalid or unconditional, the remaining provisions not affected thereby remain valid subsisting.

Section IX. - REPEALING CLAUSE. - Any ordinances, executive or administrative orders, rules or regulations and other local issuances of this LGU, contrary to or inconsistent with the provisions of this ordinance is hereby repealed, modified or amended accordingly.

Section X. - EFFECTIVITY. - This ordinance shall take effect fifteen (15) days after its publication in the Official Website and Social Media Account of the Sangguniang Bayan or by posting in three conspicuous places in this municipality

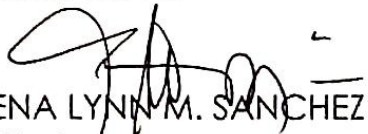

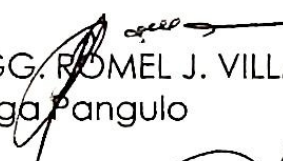

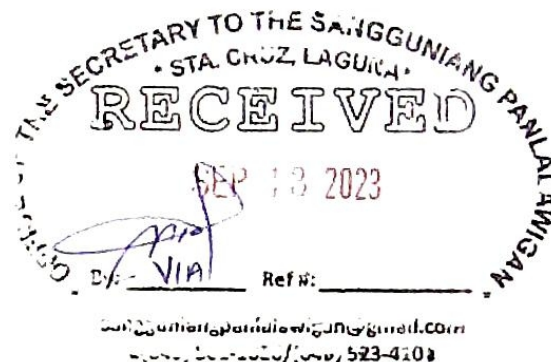
