A RESOLUTION RECOGNIZING THE OFFICIAL LIST OF IDENTIFIED CULTURAL, HISTORICAL AND HERITAGE SITES AND TO BE INCLUDED IN THE CULTURAL MAPPING PROJECTS OF THE MUNICIPALITY OF CAVINTI.

WHEREAS, Section 15, Article XIV of the 1987 Philippine Constitution provides that "The State shall conserve, promote, and popularize the nation's historical and cultural heritage and resources, as well as artistic creations";

WHEREAS, one of the policies of the State is to preserve and protect important cultural properties and national cultural treasures of the nation and safeguard their intrinsic value;

WHEREAS, the country's artistic and historic wealth constitutes as cultural treasure of the nation and shall be under the protection of the State;

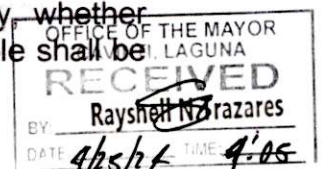
WHEREAS, under Republic Act No. 10066, otherwise known as the "The National Cultural Heritage Act of 2009" the Local Government Units, through their cultural offices, shall maintain an inventory of cultural properties under its jurisdiction and shall furnish the National Commission for Culture and the Arts (NCCA) a copy of the same;

WHEREAS, Section 7 of the Implementing Rules and Regulations (IRR) of Republic Act No. 10066 states that "The Cultural Property of the Country, whether public or privately owned, movable or immovable, and tangible or intangible shall be categorized as follows:

The following shall be declared as Grade I level:

- a) World Heritage Sites;
- b) National Cultural Treasures;
- c) National Historical Landmarks;
- d) National Historical Shrines; and
- e) National Historical Monuments

WHEREAS, Section 8 of the same IRR provides that all Cultural Properties are considered important Cultural Property such as:

- a) Works by Manlilikha ng Bayan;
- b) Works by National Artist;
- c) Archeological, traditional, ethnographic material;
- d) Works and Structures at least 50 years old;
- e) Archival materials or documents at least 50 years old;
- f) Rarebooks and Incunabula declared by the National Library of the Philippines.

WHEREAS, the Department of the Interior and Local Government (DILG) and the NCCA issued a Joint Memorandum Circular No. 2018-01, otherwise known as the "Local Inventory of Cultural Property as required under Republic Act No. 10066" enjoining the Local Chief Executives to maintain a local inventory of all cultural property within their jurisdiction;

WHEREAS, The NCCA issued Board Resolution No. 2017-330, entitled "Guidelines Governing the Philippine Registry of Cultural Property (PRECUP)" requiring the Local Cultural Database to be accompanied with a Sanggunian Resolution or ordinance recognizing it as a local inventory;

WHEREAS, thru the old records, still standing, installed, barangay profiles, as proof of it has a historical and cultural values to be identified and to include in the inventory and mapping project are as follows;
