WHEREAS, the street of Oflaria will be occupied by the ambulant vendors, trade fairs, amusement games and visitors during the celebration;

WHEREFORE, in view of the foregoing, on motion of SB Member Romel J. Villanueva duly seconded and by unanimous consent of all the members present, there being a quorum, it was

BE ENACTED by the Sangguniang Bayan of Cavinti is Session duly assembled.

SECTION 1 - That the whole street of Oflaria will be occupied by the ambulant and street vendors, trade fairs and visitors will be temporarily closed during the celebration of 10th Sambalilo Festival from August 1-17, 2024 for the said purpose;

SECTION 2 - That the portion of MH del Pilar street may also be closed should it be necessary for additional area for the ambulant vendors during the 10th Sambalilo Festival from August 1-7, 2024;

SECTION 3 - REPEALING CLAUSE. All ordinances, rules and regulations and other issuances or parts thereof inconsistent with the provisions hereof are hereby repealed or modified accordingly.

SECTION 4 - SEPARABILITY CLAUSE. If for any reason, any provision, section or any part of this ordinance is declared invalid by a court of competent jurisdiction or suspended or revolved by the Sangguniang Panlalawigan, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall remain and continue to be in full force and effect.

SECTION 5 - EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately after this publication in the official website and Social Media Account of the Sangguniang Bayan and the Municipality of Cavinti or by posting in any of the nineteen (19) Barangay Bulletin Board.

ORDERED: Let copies of this ordinance be furnished, All the agency concerned, for their immediate information, action and implementation.
