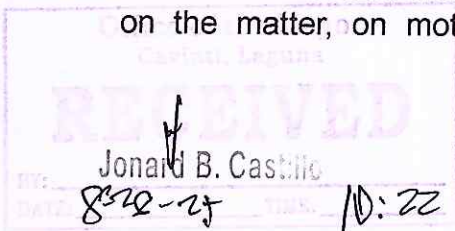
**WHEREAS**, we need to invest in training programs that would equip blue-collar workers with in-demand skills thus, increasing their earning potentials and career advancement opportunities;

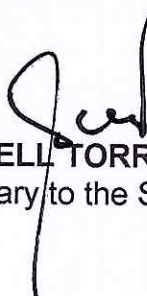
