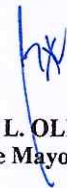
WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates every local government unit (LGU) to ensure and support, among other things, the promotion of the general welfare of its people, which includes the continuous provision of basic services such as electricity;

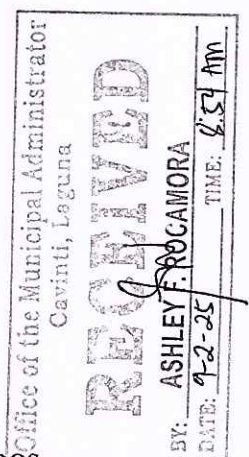
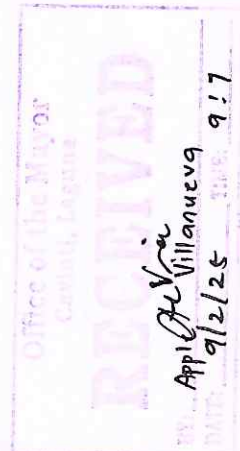
WHEREAS, Republic Act No. 9136, or the Electric Power Industry Reform Act (EPIRA Law), upholds the policy of ensuring the quality, reliability, security, and affordability of the supply of electric power to consumers, and mandates electric cooperatives to promote uninterrupted and efficient power delivery to all service areas;

WHEREAS, the Municipality of Cavinti currently relies primarily on its electrical supply from the Caliraya line, and frequent power interruptions have significantly disrupted economic activities, tourism operations, agricultural production, and delivery of essential public services;

WHEREAS, the establishment of such a connection is consistent with the policies of the EPIRA Law and the LGU's mandate to secure public welfare by supporting economic growth, disaster resilience, and community development;

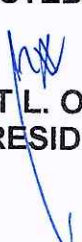
