WHEREAS, the Municipality of Cavinti remains a largely agricultural community where farming and agri-based livelihoods serve as the main source of income and sustenance for many households;

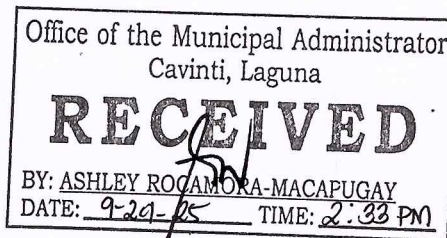
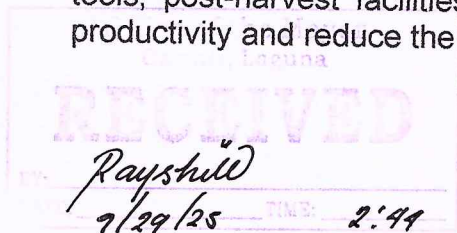
