**WHEREAS**, the Municipality of Cavinti upholds the principles of good governance and is committed to promoting "Serbisyong May Puso at Husay" for all its constituents;

NOW THEREFORE, in view of the foregoing, after mature deliberation on the matter, on motion of SB Romel J. Villanueva, duly seconded and unanimously approved by all other SB Members herein present, there being a quorum, it was

## RESOLVED, as it is hereby RESOLVED, that:

- All municipal departments, offices, and units are directed to strictly comply with RA 11032 and post their updated Citizen's Charters immediately.
- 2. All offices shall observe the following service delivery standards:
  - a. No long lines adopt queue or appointment systems.
  - No cut-off system clients shall be served during official working hours.
  - c. No noon breaks ensure continuous service delivery through shifting schedules.
  - d. No fixers strictly prohibited and punishable under the law.
  - e. No undocumented steps only processes in the Citizen's Charter shall be required.
- 3. A Municipal ARTA Monitoring Committee, chaired by the Municipal Administrator with representatives from each office and the private sector, shall oversee and monitor compliance.
- 4. Department Heads shall be held accountable for the full implementation of these measures in their respective offices.
- 5. Violations shall be dealt with in accordance with Section 21 of RA 11032, including suspension, dismissal, perpetual disqualification from public office, fines, and imprisonment, depending on the gravity of the offense.

RESOLVED FURTHER, that copies of this Resolution be furnished to all LGU offices, Barangay Councils, and Sangguniang Kabataan (SK) Councils of Cavinti for their information, and to encourage the barangay officials and the youth to actively report any observed violations to ARTA through the ARTA Hotline 1-2782, 8888, and the Municipal PACD.
