WHEREAS, the Local Government Code of 1991 (R.A. 7160) mandates the Sangguniang Bayan to adopt measures that ensure the health, safety, and general welfare of the inhabitants, and promote good governance at all levels;

WHEREAS, the Department of the Interior and Local Government (DILG) institutionalized the Seal of Good Local Governance for Barangays (SGLGB), which serves as a progressive performance assessment and recognition system for all barangays to continuously improve their performance across various governance areas;

WHEREAS, the operational guidelines for the SGLGB program are consistently disseminated through DILG issuances, notably Memorandum Circular No. 2023-103 (CY 2023 Seal of Good Local Governance for Barangay - SGLGB) and subsequent updates, which define the strict criteria for financial administration, disaster preparedness, social protection, peace and order, and environmental management, among others;

WHEREAS, adherence to the SGLGB standards is paramount to achieving the principles of transparency, accountability, and excellence in the delivery of basic services, thereby ensuring that the constituents of the Municipality of Cavinti receive efficient, equitable, and quality public services;

WHEREAS, the collective compliance of all nineteen (19) Sangguniang Barangays will elevate the overall governance standing of the Municipality of Cavinti and unlock potential incentives and capacity development interventions from the National Government;

NOW, THEREFORE, after due deliberation on the matter, upon motion of SB Member Romel J. Villanueva, duly seconded and unanimously approved by all other SB Members herein present, in a session duly assembled, there being a quorum, it was

RESOLVED, as it is hereby resolved, by the Sangguniang Bayan of the Municipality of Cavinti, Laguna, in session assembled, to URGE AND MANDATE all nineteen (19) Sangguniang Barangays to STRICTLY ADHERE TO THE MANDATES AND GOVERNANCE AREAS PRESCRIBED UNDER THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAYS (SGLGB) PROGRAM, ensuring full documentary and functional compliance for the succeeding assessment periods;

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Municipal Mayor, the Acting Municipal Administrator, the Municipal Local Government Operations Officer (MLGOO), and all nineteen (19) Sangguniang Barangays, for their immediate attention and appropriate action.

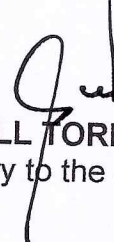
